This can be done either by pre-filling their arrival information through the official [National Immigration Administration Government Service Platform](#) of People of Republic of China before departure or by completing their Arrival Card at a port of entry in Mainland China.

Participants from other countries/regions can refer to the relevant government authorities to check their visa requirements for entry to Mainland China and the Hong Kong and Macao Special Administrative Regions.
